#### **PUBLIC FORUM**

#### 44 <u>Windmill Cottages</u>

The cottages continue to be uninhabited. A resident who has sought to gain clarification from the Trust noted that responses received were not conclusive and did not indicate that any action could be anticipated soon.

- Another resident, who is involved with the Trust, confirmed that the Trust is considering what action could be taken but currently they do not have sufficient funds to bring the cottages back into a habitable state. A grant application has been submitted to South Norfolk and the outcome will be known shortly. However, with regard to timescales it is likely to be years rather than months before any action is taken; in the intervening period the cottages are likely to fall into further disrepair.
- The County Councillor did put the Trust in contact with Saffron Housing, who manage the social housing for South Norfolk. However, Saffron indicated that the cost of any refurbishment would be significant and they were unable to offer any support. It is understood the market value of the two properties is in the region of £340K but due to the manner of the gift the Trust is unable to sell them.

- It was noted that children were seen climbing to the top of the newly trimmed hedges around the Playing Fields and will be monitored to see if this reoccurs.

#### 62 Acoustics Survey:

ETS have confirmed they are unable to assist with the acoustic problem in the Village Hall and recommend seeking the advice of a specialist acoustic engineer. It was noted that Adrian James will charge £495 plus VAT to conduct a survey but do not carry out the work themselves, rather suggesting that a builder is engaged to carry out the installation work.
