AGENCY GRASS CUTTING

- 343 This contract is renewed annually with the County Council; when confirmation is received the Parish Council is then able to confirm, annually, with contractors for carrying out the work.
- 344 Three quotes for both Urban and Rural grass cutting were received. It was agreed that the preferred option is to award contracts to local businesses.

Resolved: to award the Urban cut to Tim's Gardening Services (6 cuts for £270 total) and award the Rural cut to B Clarke (3 cuts for £1,050 total) subject to confirmation from the County Council that the Agency agreement will be continued during 2013/14. Proposed by JH, seconded by SM. All in agreement.

PLANNING

345 <u>2013/0226: Land west of Sheldrake Farm, Low Road, Wicklewood</u> Proposed new residential dwelling and access.

PLAYING FIELD

346 B Clarke will cut the conifers around the playing field, if approved, for £35.00. MG suggested that the small triangle to the left of the Village Hall entrance requires cutting and to include in the work.

- 347 <u>Tree trimming:</u> this work will be carried out shortly, dependent on weather.
- 348 <u>Wire Netting Cricket Club</u>: this has fallen down and may cause an obstruction to the

grass cutting equipment. The Cricket Club confirm that the netting will either be repaired or removed in the near future.

Two inspections have been carried out to the play equipment on 11th and 25th 349 February. Nothing to report.

- 351 Replacement of Village Hall Roof

The Cinema Group have requested confirmation that the Parish Council will pay for the removal and replacement on their equipment. Costs will amount to £433.36. LL will speak with Kimberley Electrical, who included this work in their quotations, to seek a revised quotation.

Resolved: that the Parish Council will pay the costs associated with the removal and replacement of the cinema equipment as per costs provided, £433.36 as part of the works to the Village Hall. Proposed by LL, seconded by JH. All in agreement.

- 352 Wooden Floor: One quotation has been received. Clerk is meeting a second contractor on to obtain a further quote for consideration. Agreed that MG and JH will MG & make this decision on receipt of the second quotation. All in agreement. JH
- 353 Allotments: Clerk to contact all those on the waiting list to enquire if they still wish to rent an allotment. A further enquiry/request to rent the available plot has recently AP been received. It was noted that the tenant on No. 3 plot has expanded into the neighbouring plot. Allocation of allotments to be discussed further in April on receipt of responses.
