Trees	Users of the allotments may suffer injuries or death due to unsafe or falling branches or trees from neighbouring properties.	<ul style="list-style-type: none"> Regular inspection of area 	<ul style="list-style-type: none"> No further action needed. 			
Defective ground surface eg. Holes	Users of the allotments may suffer injuries such as fractures or bruising if they trip or fall.	<ul style="list-style-type: none"> Regular maintenance of walkways and inspection of area. 	<ul style="list-style-type: none"> No further action needed. 			
Vehicle movement (general)	Users of allotments could suffer serious injury or death if struck by moving vehicle.	<ul style="list-style-type: none"> General prohibition of vehicles applies except for allotment users and emergency purposes only. To reduce vehicle movements, allotment holders asked to park in car park unless moving heavy items to/from their plot 	<ul style="list-style-type: none"> Provide 'No unauthorised motor vehicles' and speed limit signs. Overhead electricity cables	Users of allotments could be electrocuted if in contact with the overhead cables	Advise allotment holders of overhead electricity cables and not to use any long objects that can come into contact with the electricity cables. Used Needles	Users of the allotments may suffer HIV, Hepatitis B, etc.	<ul style="list-style-type: none"> • Regular inspection of area. Not considered to be a high risk area.	<ul style="list-style-type: none"> • Safe litter-picking by person trained to deal with sharps. • Procedure requires use of personal protective clothing/equipment • Formal arrangement required for safe disposal of material collected.
