Summary of my recommendations

I would like to thank the Parish Clerk for supplying me with all the information required for carrying out the audit.

Receipts and payments method is used as the basis for accounting. All documentation is filed in date order and clearly referenced. The clerk demonstrates good practice in her recording of transactions.

The cashbook is well maintained. The bank is reconciled monthly, and this is reported to the council. There is no petty cash.

Progress against the budget is recorded in the minutes.

The village hall has a dedicated booking clerk with details available on the website.

Allotment rents have been increased this year and it is the responsibility of the RFO to ensure that all money due is collected.

In conclusion, I am satisfied that this parish council is functioning well and is discharging its legal and statutory responsibilities.
